AN ACT 'TO PROVIDE FOR THE RESUSCITATION AND CONTINUANCE IN FORCE OF THE DEFENCE REGULA-TIONS (EXTENSION) ACT, NO. 24 OF 1950, WHICH EXPIRED AFTER DECEMBER 9, 1964, AND FOR THE VALIDATION FENDERED NECESSARY BY SUCH EXPIRY.

[Date of Assent: November 24, 1968]

BE it enacted by the Queen's Most Excellent Majesty, lby and with the advice and consent of the Senate and the House of Representatives of Ceylon in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Defence Regulations (Resuscitation) Act, No. 41 of 1968.

2. (1) The Defence Regulations (Extension) Act, No. 24 of 1950, which, by virtue of a resolution passed lby the Senate and the House of Representatives under section 6 of that Act, continued in force until December '9, 1964, and then expired, shall be deemed to have lbeen in force during the period commencing on the date of such expiry and ending on the day immediately preceding the date of the commencement of this Act and to be in force thereafter until December 31, 1968, as if the aforesaid resolution had declared that the Defence Regulations (Extension) Act, No. 24 of 1950, shall continue in force tor any further period or periods in the manner prescribed in section 6 of that .Act.

(2) All such orders and instruments as were made under any of the Defence Regulations specified in the Defence Regulations (Extension) Act, No. 24 of 1950, and were in force at the time of the expiry of that Act schall be deemed to have been in force during the period commencing on the date of expiry of that Act and cending on the day immediately preceding the date of the commencement of this Act and to be in force theresafter until they are rescinded or annulled or until they expire.
