AN ACT TO VALIDATE CERTAIN REGULATIONS MADE  
UNDER THE IMPORTS AND EXPORTS (CONTROL) ACT,  
No. 1 OF 1969.

[Date of Assent: December 28, 1971]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the House of Representatives of Ceylon in this present Parliament assembled, and by the authority of the same, as follows:

1. This Act may be cited as the Imports and Exports Regulations (Validation) Act, No. 57 of 1971.

Short title.

2. The regulations specified in the First Schedule to this Act which were made by the Minister of State under the Imports and Exports (Control) Act, No. 1 of 1969, and the regulations specified in the Second Schedule to this Act which were made by the Minister of Commerce and Trade under the aforesaid Act shall be deemed to be and to have always been valid and effectual, notwithstanding that the requirements of section 20 of the aforesaid Act relating to the approval by the Senate and the House of Representatives had not been complied with in the case of those regulations.
