A Law to Amend The Registration of Documents Ordinance

BE it enacted by the National State Assembly of the Republic of Sri Lanka as follows:—

1. This Law may be cited as the Registration of Shorttitle. Documents (Amendment) Law, No. 19 of 1976.

2. The Registration of Documents Ordinance is hereby amended in the First Schedule thereto as follows:—
