BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:—

1. This Act may be cited as the Local Authorities (Special Provisions) (Amendment) Act, No. 12 of 1979.

Short title.

2. The long title of the Local Authorities (Special Provisions) Act, No. 3 of 1979, hereinafter referred to as the "principal enactment", is hereby amended by the substitution for the words "LOCAL GOVERNMENT SERVICE.", of the words "LOCAL GOVERNMENT SERVICE AND FOR MATTERS CONNECTED THEREWITH OR INCIDENTAL THERETO.".
