Department of Prisons—Prisoners' Welfare Fund (Amendment) Act, No. 54 of 1979

An Act to amend the Department of Prisons—Prisoners' Welfare Fund Law, No. 18 of 1973.

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:—

- 1. This Act may be cited as the Department of Prisons—Prisoners' Welfare Fund (Amendment) Act, No. 54 of 1979.
- 2. Section 4 of the Department of Prisons—Prisoners' Welfare Fund Law, No. 18 of 1973 (hereinafter referred to as the "principal enactment") is hereby amended by the insertion immediately after paragraph (a) of that section, of the following new paragraph:—

Amendment to section 4 of Law No. 18 of 1973.

Short title.

- " (aa) any such sum of moneys lying to the credit of any prisoner in the General Deposit—Prisoners' Wages and Private Cash Account, as remains unclaimed for a period of not less than one year from the date of release of such prisoner;".
- 3. Section 5 of the principal enactment is hereby amended as follows:—

Amendment to section 5 of the principal enactment.

- (i) by the substitution, for the fullstop appearing at the end of that section, of a semi-colon; and
- (ii) by the insertion at the end of that section of the following new paragraph:—
 - "(f) such after-care services as would help in the rehabilitation of prisoners after their discharge from prison.".
