AN ACT TO PROVIDE FOR THE CONTINUANCE IN FORCE,
AFTER DECEMBER 9, 1950, OF DEFENCE REGULATIONS
FOR THE CONTROL OF IMPORTS AND EXPORTS.

[Date of Assent: October 20, 1950.]

WHEREAS the Defence Regulations which have effect by virtue of the Supplies and Services (Transitional Powers) Act, 1945, of the Parliament of the United Kingdom are due to expire on the tenth day of December, 1950:

AND Whereas it is expedient to provide for the continuance in force for a further period of certain of those Defence Regulations which provide for the control of imports and exports:

BE it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives of Ceylon in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Import and Export Control (Continuation) Act. No. 27 of 1950, and shall come into operation on the ninth day of December, 1950, (hereinafter referred to as "the appointed date").

2. (1) The Defence Regulations, specified in the First Schedule to this Act shall from the appointed date have the force of law by virtue of this Act and as though they were herein enacted.

(2) The Defence Regulations specified in the Second Schedule to this Act shall from the appointed date have the force of law by virtue of this Act and as though they were herein enacted, so however that references in any of the said Regulations to any defence regulation shall be construed as references only to any of the Defence Regulations specified in the First Schedule to this Act.

3. The Governor-General may, by Order published in the *Gazette*, declare that any Defence Regulation specified in the Schedules to this Act shall cease to be in force on such date as may be specified in the Order.

4. References in this Act to Defence Regulations shall be deemed to include references to all Orders and instruments heretofore made or issued thereunder and in force at the appointed date.
