AN ACT TO AMEND THE SURVEYORS ORDINANCE

[Date of Assent: October 20, 1950.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives of Ceylon in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Surveyors (Amendment) Act, No. 28 of 1950.

Short title.

2. (1) Section 5 of the Surveyors Ordinance (hereinafter referred to as "the principal enactment") is hereby amended, by the substitution, for the words "two rupees and fifty cents", of the words "five rupees".

(2) The amendment made in section 5 of the principal enactment by sub-section (1) of this section shall come into force on such date as may be appointed by the Minister by Order published in the *Gazette*.

3. Section 12 of the principal enactment is hereby repealed.

4. Schedule A to the principal enactment is hereby amended as follows:—

(1) by the omission of paragraphs 8, 9 and 11 thereof;

(2) by the re-numbering of paragraphs 10, 12, 13, 14, 15 and 16 thereof as paragraphs 8, 9, 10, 11, 12 and 13 respectively;

(3) by the substitution, for the re-numbered paragraph 9, of the following new paragraph:—

" 9. Every person who has served in the Survey Department as—

(1) Surveyor-General, or

(2) Deputy Surveyor-General, or

(3) Assistant Surveyor-General, or

(4) a Superintendent of Surveys, or

(5) an Assistant Superintendent of Surveys, or

- (6) a Senior Survey Assistant, or
- (7) a First Grade Surveyor, or
- (8) a Second Grade Surveyor, or
- (9) a Third Grade Surveyor for a period of more than fifteen years, or
- (10) a Third Grade Surveyor for a period of more than ten years and passed the Junior Examination of the Survey Department:

Provided, however, that any of the periods referred to in sub-paragraphs (9) and (10) may, in exceptional cases, be reduced to a shorter period by the Minister on the recommendation of the Surveyor-General"; and

- (4) by the substitution, for the re-numbered paragraph 13, of the following new paragraph:—

“ 13. Any person referred to in paragraph 9 who has been declared medically to be unfit for service in the Survey Department, but who, in the opinion of the Surveyor-General after such medical examination as the Surveyor-General considers necessary, is fit to practise as a licensed surveyor.”
