AN ACT TO AMEND THE PUBLIC OFFICERS (SECURITY) ORDINANCE.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives of Ceylon in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Public Officers (Security) (Amendment) Act, No. 27 of 1952.

Short title.

2. Sections 2 and 3 of the Public Officers (Security) Ordinance, (hereinafter referred to as the "principal enactment"), are hereby amended as follows:—

Amendment of sections 2 and 3 of Chapter 251.

(1) by the substitution, for the words "Deputy Secretary to the Treasury", wherever those words occur in those sections, of the words "Permanent Secretary to the Ministry"; and

(2) by the substitution, for the words "Secretary to the Treasury", wherever those words occur in those sections, of the words "Deputy Secretary to the Treasury".

3. Section 4 of the principal enactment is hereby amended as follows:—

Amendment of section 4 of the principal enactment.

(1) by the substitution, for the words "Deputy Secretary to the Treasury", of the words "Permanent Secretary to the Ministry"; and

(2) by the substitution, for the words "approved by the Secretary to the Treasury", of the words "approved by the Deputy Secretary to the Treasury".

4. Section 5 of the principal enactment is hereby amended by the substitution, for the words "Deputy Secretary to the Treasury", wherever those words occur in that section, of the words "Permanent Secretary to the Ministry".

5. Section 6 of the principal enactment is hereby amended as follows:—

- (1) by the substitution, for the words “Deputy Secretary to the Treasury,”, wherever those words occur in that section, of the words “Permanent Secretary to the Ministry”;
- (2) in sub-section (1) of that section, by the substitution, for the words “approved by the Secretary to the Treasury”, of the words “approved by the Deputy Secretary to the Treasury”; and
- (3) in sub-section (3) of that section, by the substitution, for the words “Secretary to the Treasury”, wherever those words occur in that sub-section, of the words “Deputy Secretary to the Treasury”.

6. Sections 7, 8 and 10 of the principal enactment are hereby amended by the substitution, for the words “Deputy Secretary to the Treasury”, wherever those words occur in those sections, of the words “Permanent Secretary to the Ministry”.

7. Section 11 of the principal enactment is hereby amended as follows:—

- (1) by the substitution, for the words “Deputy Secretary to the Treasury”, wherever those words occur in that section, of the words “Permanent Secretary to the Ministry”; and
- (2) by the substitution, for the words “Secretary to the Treasury”, wherever those words occur in that section, of the words “Deputy Secretary to the Treasury”.
