AN ACT TO AMEND THE REGISTRATION OF DEATHS
(EMERGENCY PROVISIONS) ORDINANCE, NO. 24 OF
1945.

[Date of Assent: November 13, 1952]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives of Ceylon in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Registration of Deaths (Emergency Provisions) (Amendment) Act, No. 37 of 1952.

Short title.

2. Section 11 of the Registration of Deaths (Emergency Provisions) Ordinance, No. 24 of 1945, is hereby amended as follows:—

(1) in the definition of “ a person subject to military law ”, by the substitution, for paragraphs (a), (b) and (c), of the following new paragraphs:—

“ (a) a member of the Ceylon Army, the Royal Ceylon Navy, or the Ceylon Air Force, who is absent from his unit on leave or otherwise than on duty; or

(b) a member of the Ceylon Army, the Royal Ceylon Navy, or the Ceylon Air Force, who is on the Reserve thereof; or

(c) a citizen of Ceylon who is a member of any of His Majesty's regular forces and who is absent from his unit on leave or otherwise than on duty; ”;

(2) by the repeal of the definition of the expression “ Ceylonese ”; and

(3) in the definition of “ His Majesty's forces ”, by the substitution, for the words “ Ceylon Defence Force, the Ceylon Royal Naval Volunteer Reserve, the Ceylon Air Defence Corps ”, of the words “ the Ceylon Army, the Royal Ceylon Navy, the Ceylon Air Force ”.
