ACT TO AMEND THE URBAN COUNCILS ORDINANCE, NO. 61 OF 1939, THE TOWN COUNCILS ORDINANCE, NO. 3 OF 1946, AND THE VILLAGE COMMUNITIES ORDINANCE, AND TO VALIDATE CERTAIN ACTS DONE WITHOUT LEGAL AUTHORITY BY PERSONS LEGALLY APPOINTED TO ADMINISTER THE AFFAIRS OF TOWNS OR VILLAGE AREAS WHOSE URBAN OR TOWN COUNCILS OR VILLAGE COMMITTEES WERE DISSOLVED.

E it enacted by the Queen's Most Excellent Majesty, and with the advice and consent of the Senate and House of Representatives of Ceylon in this premt Parliament assembled, and by the authority of e same, as follows:—

**1.** This Act may be cited as the Local Authorities pecial Provisions) Act. No. 2 of 1957.

4. Section 62 of the Village Communitie Ordinance, as amended by Ordinance No. 57 of 1946 is hereby further amended in paragraph (c) of that section—

- (a) by the substitution, for the words "direct the Assistant Commissioner", of the word "directs any public officer", and
- (b) by the substitution, for all the words "rol "powers vested" to "discharge b him,", of the following:—

"powers vested in the Committee of its Chairman by this Ordinance or any other written law shall be deemed to b vested in that public officer, and all th liabilities and duties of the Committee or its Chairman under this Ordinance or any other written law shall be deemed to be transferred to and shall be discharged by that public officer,".

5. Where any person appointed—

(a) under section 196 (5) of the Urban Counci

- Ordinance, No. 61 of 1939, or section 18 (5) of the Town Councils Ordinance, No. of 1946, to administer the affairs of a town or
- (b) under section 61 of the Village Communiti-Ordinance to administer the affairs of village area,

has done any act in the exercise or discharge of an power or duty vested or imposed by any written la in or on the Chairman of the Urban or Town Counc of that town or the Chairman of the Village Conmittee of that area, such act shall not be deemed have been or to be invalid by reason only of the fa that such person was not legally empowered exercise or discharge such power or duty.

Validation of certain acts done without legal authority by persons appointed to administer the atlairs of towns or village areas whose Urban or Town Councils or Village Committees were dissolved.
