ACT TO AMEND THE TEA RESEARCH ORDINANCE, THE RUBBER RESEARCH ORDINANCE AND THE COCONUT RESEARCH ORDINANCE.

[Date of Assent; March 18, 1957]*

BE it enacted by the Queen's Most Excellent jesty, by and with the advice and consent of the ate and the House of Representatives of Ceylon this present Parliament assembled, and by the Ihority of the same, as follows:—

.. This Act may be cited as the Tea, Rubber and conut Research (Amendment) Act, No. 8 of 1957.

Short title.

The Tea Research Ordinance is hereby amended the addition, immediately after section 13 of that Hinance, of the following new section which shall re effect as section 14:—
