ACT TO AMEND THE TEA RESEARCH ORDINANCE, THE
RUBBER RESEARCH ORDINANCE AND THE COCONUT
RESEARCH ORDINANCE.

[Date of Assent: March 18, 1957]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives of Ceylon this present Parliament assembled, and by the Authority of the same, as follows:—

1. This Act may be cited as the Tea, Rubber and Coconut Research (Amendment) Act, No. 8 of 1957.

Short title.

2. The Tea Research Ordinance is hereby amended by the addition, immediately after section 13 of that Ordinance, of the following new section which shall have effect as section 14:—

Addition of new section 14 to Chapter 301.

14. In the exercise of its powers, the performance of its duties and the discharge of its functions, the Board shall be subject to, and act in accordance with, such general directions as the Minister may issue from time to time.”

Minister's directions to the Board.

3. The Rubber Research Ordinance is hereby amended by the insertion, immediately after section 9 of that Ordinance, of the following new section which shall have effect as section 9A:—

Insertion of new section 9A in Chapter 302.

9A. In the exercise of its powers, the performance of its duties and the discharge of its functions, the Board shall be subject to, and act in accordance with, such general directions as the Minister may issue from time to time.”

Minister's directions to the Board.

4. The Coconut Research Ordinance, as amended by Act No. 31 of 1951, is hereby further amended as follows:—

Amendment of section 3 of, and insertion of new section 10A in, Chapter 303.

(1) in section 3 (1) of that Ordinance, by the addition, at the end of paragraph (a), of the words “ The Commissioner of Coconut Rehabilitation.”; and

(2) by the insertion, immediately after section 10 of that Ordinance, of the following section which shall have effect from the commencement of this Act:

10A. In the exercise of its powers and in the performance of its duties and in the discharge of its functions, the Board shall be subject to, and act in accordance with, such general directions as the Minister may issue from time to time."
