## CHAPTER 117

## REGISTRATION OF DOCUMENTS (AMENDMENT)

Acts Nos. 22 of 1958, 11 of 1963. An Act to amend the Registration of Documents Ordinance.

[Section 2 (1)—1st January, 1928.] [Sections 3 to 5—9th May, 1958.] [Section 6—21st December, 1963]

Short title.

1. This Act may be cited as the Registration of Documents (Amendment) Act.

Amendment of section 14 of Chapter 117.
[§ 2, 22 of 1958.]

- 2. (1) Section 14 of the Registration of Documents Ordinance, hereinafter referred to as the "principal enactment", is hereby amended, in subsection (1) thereof, as follows:—
  - (a) in paragraph (a) of that subsection by the substitution, for the words "thereof; and", of the word "thereof;";
  - (b) in paragraph (b) of that subsection by the substitution, for the word "Registrar.", of the words "Registrar; and"; and
  - (c) by the insertion, immediately after paragraph (b) of that subsection, of the following paragraph:—
    - '(c) where a new division of a Registrar is created wholly or partly out of a division (hereinafter referred to as the "old division") of another Registrar, then, in regard to lands which before the date of creation of the new division were wholly or partly within the old division which on and after that date constitutes the new division or, as the

case may be, within such part of the old division as on and after that date constitutes a part of the new division,—

- (ii) a registration of an instrument affecting any such land made in the new book and registrations of instruments affecting that land made in the old book shall be connected by cross references made in the prescribed manner in the new book and the old book.'.
- (2) The amendments made in section 14 of the principal enactment by subsection (1) of this section shall be deemed to have come into force on the date of commencement of the principal enactment.
- 3. The following new heading is hereby substituted for the heading "REGISTRATION OF BILLS OF SALE." occurring in Chapter IV of the principal enactment:—

[§ 3, 22 of 1958.]

"REGISTRATION OF INSTRUMENTS CREATING PLEDGES, MORTGAGES OR BILLS OF SALE OF MOVABLE PROPERTY.".

## REGISTRATION OF DOCUMENTS (AMENDMENT)

Amendment of heading in Chapter V of the principal enactment. [§ 4, 22 of 1958.]

- 4. The following new heading is hereby substituted for the heading "PROVISIONS APPLICABLE TO INSTRUMENTS AFFECTING LAND AND PLEDGES, MORTGAGES, OR BILLS OF SALE." occurring in Chapter V of the principal enactment:—
  - "PROVISIONS APPLICABLE TO INSTRUMENTS AFFECTING LAND OR PLEDGES, MORT-GAGES OR BILLS OF SALE OF MOVABLE PROPERTY.".

Amendment of section 40 of the principal enactment.
[§ 5, 22 of 1958.]

- 5. Section 40 of the principal enactment is hereby amended as follows:—
  - by the substitution, for the words "volume of duplicates or copies", of the words "volume or any part of any volume of duplicates or copies";
  - (2) by the substitution, for the words "volume of any book", of the words "volume or any part of any volume of any book";
  - (3) by the substitution, for the words "copy thereof", of the words "copy of the volume or part so damaged or in danger of becoming illegible";
  - (4) by the substitution, for the words "the volume so damaged", of the words "the volume or part so damaged"; and
  - (5) in the marginal note to that section by the substitution, for the word "volumes.", of the words "volumes or parts thereof.".

Amendment of the First Schedule to the principal enactment. [§ 51, 11 of 1963.]

- 6. The First Schedule to the principal enactment is hereby amended, in Part III of that Schedule, as follows:—
  - (a) in item 1, by the substitution, in paragraph (a) of that item, for the figures "1.0", of the figures "2.0"; and
  - (b) in item 3, by the substitution, for the figures "0.50", of the figures "1.0".
